## **Bursary Terms & Conditions**

NAATSIHWP is offering **reimbursement** of travel, accommodation and/or registration fee for eligible FULL and STUDENT members based on the Modified Monash Model:

- Up to \$1,500 reimbursement of travel costs for members within MMM 4-7 (TIER 1)
- Up to \$750 reimbursement of travel costs for members within MMM 1-3 (TIER 2)
- Reimbursement of registration fee for members within the Perth Region (TIER 3)

#### **Eligibility Requirements**

  - A personal statement outlining how the bursary will assist you in attending the NAATSIHWP Conference
  - NAATSIHWP assessment or confirmation of Full/Student membership
